1. A. Eligibility criteria for participation in the tender:

No. – 02 & 03} /Valid Trade License/Voter ID or Aadhaar Card for self-identification to be accompanied with the Technical Bid Documents to be submitted. [Non-statutory Documents].

B. Bid Evaluation:

The process will go through two steps of Technical Evaluation & Financial Evaluation. Thus, two separate sealed envelopes containing **Technical and Financial** offer separately submitted by the quotationer.

The 02 (two) sealed covers must be sealed in another bigger cover and the outer cover also must be sealed. The outer cover also must be superscripted with Name of the work, Name of firm with address of the firm / bidder and to be duly addressed to the undersigned. Any participant/bidder not following the steps in submitting their bid / offer as described in this para shall be disqualified

- 2. The Bidder must apply in the company letter pad for purchasing the Tender documents. No technical documents need to be submitted at the time of application for purchasing the Tender documents.
- 3. Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, laboratory etc. at their own cost and responsibility.
- 4. All materials should be supplied by the Contractor/agency.
- 5. **Construction Labour Welfare Cess** @ 1(one) % of cost of construction will be deducted from every Bill of the selected agency.
- 6. Provision of Arbitration is replaced through provision of Dispute Redressal Committee as contained in Finance Dept. notification no 8182-F(Y) dated 26.09.2012 of the Secretary, to the Govt. of West Bengal and relevant clause i.e. cl 25 of 2911(ii) is modified accordingly.
